

LIBERTY TOWNSHIP SPEED LIMIT ORDINANCE

ORDINANCE NO. 2-93, 1993

AN ORDINANCE ESTABLISHING SPEED LIMITS ON LIBERTY TOWNSHIP ROADS BASED ON SECTION 3362 AND 3363 OF THE PENNSYLVANIA VEHICLE CODE AND SECTION 201.31 OF THE PENNDOT REGULATIONS ON SPEED RESTRICTIONS AND ESTABLISHING FINES FOR VIOLATION OF SAID SPEED LIMITS.

Be it enacted and ordained by the Board of Supervisors of Liberty Township, Adams County, Pennsylvania, that for public health and safety the following speed limits are hereby established.

WHEREAS, The Board of Supervisors, after considering a speed study of the township roads and after adequate public hearing and notice, recognize the need to establish speed limits on certain township roads; and,

WHEREAS, the Board of Supervisors, finds that the following speed limits are the maximum safe speeds on Township roads as designated herein;

NOW, THEREFORE, be it enacted and ordained as follows:

SPEED LIMITS ESTABLISHED. The following speed limits are hereby established:

Boyle Road	1.0	Tract Road and Freedom Township line	35 mph
Brent Road	0.3	Tract Road and end of township ROAD	25 mph
Bull Frog Road	1.6	Hamiltonban Township line and Freedom Township line	35 mph
Crum Road	1.5	Tract Road and L.R. 16	35 mph
Girl Scout Road	0.4	Bull Frog Road and Water Street Extended	35 mph

Road	Miles	Between	Speed Limit
Gladhill Road	1.6	Harbaugh Valley Road and Washington Township line	35 mph
Irishtown Road	0.5	Boyle Road and Maryland line	35 mph
Liberty Hall Road	0.3	Tract Road and Water Street Extended	25 mph
McGlaughlin Road	1.0	Bull Frog Road and Water Street Extended	35 mph
Old Waynesboro Road	0.5	L.R. 16 and Jacks Mountain Road	35 mph
Orchard Road	0.9	L.R. 16 and Tract Road	35 mph
Pecher Road	2.3	Tract Road and Steel-Marker Road intersection	40 mph
Sanders Road	0.6	Tract Road and Carroll Valley Borough line	25 mph
Topper Road	0.9	Steelman Marker Road intersection and Orchard Road	40 mph
Wenschhof Road	0.9	Tract Road and Steelman Marker Road intersection	35 mph

Any person who shall operate a vehicle or tractor at a speed over that established therefor, upon any road or portion thereof specified in this ordinance, shall, upon conviction thereof, be sentenced to pay a fine of thirty-five (\$35.00) dollars and costs of prosecution, plus an additional fine of two (\$2.00) dollars per mile for each mile in excess of five miles per hour over the maximum speed limit, or, in default of payment of such fine and costs, to undergo imprisonment for one (1) day for each ten (\$10.00) dollars of such fine and costs.

**Effective Date.** This Ordinance shall become effective thirty (30) days after the date same shall have been adopted by the Township Supervisors.
